

Thank you for joining the Department for Levelling Up, Housing and Communities (DLUHC) and members of the 'Tackling the Root causes Upstream of Unhealthy Urban Development' (TRUUD) research consortium to explore how we can create healthier urban environments. There has been a huge amount of interest in this event, which we are delighted to say is running at full capacity. We have an extremely impressive delegate list that includes representatives from the devolved nations, numerous government departments and executive agencies, combined and local authorities from across the country and distinguished leaders from the private sector, think tanks and UK funding councils.

The expression of interest in this event reflects the timely need to think creatively about addressing the UK's public health challenges. Non-communicable diseases such as diabetes, heart disease or asthma account for 89 per cent of deaths in England and ill-health among working-age people is estimated to cost £150 billion a year. While the associations between health outcomes and urban design are increasingly evidenced, those that control the development of urban areas are frequently falling short of creating the environments that will protect and improve health. Of greatest concern is that the most disadvantaged in society frequently live in the worst conditions, which is widening existing health inequalities. One way to improve and protect public health and reduce this economic burden is through the design and quality of urban development.

This one-day event brings together critical stakeholders from across the urban development system to discuss innovative and evidence-based ways to create healthier urban environments. It will explore how systems thinking can be utilised to promote cross-government and cross-sector working in a bid to achieve long-term, preventative measures to improve public health. The event is co-hosted by DLUHC and a 6-year research programme called TRUUD. DLUHC and TRUUD have been working in collaboration to explore the best ways to incorporate health outcomes and disparities in urban development decision-making. Your participation and contribution to this event will be critical in shaping our ongoing work.

Every person in attendance has the potential to influence decision making in this space. The event is designed as a 'call to action' to think and behave in an informed and positive way to promote health outcomes in urban development. We hope that it is the start of new conversations and connections and the sharing of evidence and data to enable a joined-up, systems approach to one of society's most pressing challenges improving public health and tackling health inequality.

#### About TRUUD

Tackling Root causes upstream of Unhealthy Urban Development (TRUUD) is a research project, based at the University of Bristol, looking at how urban centres can be planned to reduce health inequalities. The TRUUD consortium includes the Universities of Bath, Bristol, Reading, Manchester, Stirling and the University of the West of England across disciplines of public health, law, psychology, management, systems engineering, environmental and health economics, real estate, planning, urban development, policy and public involvement.

TRUUD has created an economic valuation model - Health Appraisal of Urban Systems (HAUS) - that allows policy officials, developers and planners to quantify how changes in an area might affect health. The HAUS model provides information on three key elements (i) incidence of ill health attributed to different features of the urban environment (ii) the financial costs associated with that ill health and (iii) where in the system those costs are incurred, which is often outside the health sector. TRUUD is working with DLUHC to adapt HAUS for use in the department and to integrate it into their appraisal guidance.

TRUUD is supported by the UK Prevention Research Partnership (UKPRP), an initiative funded by UK Research and Innovation Councils, the Department of Health and Social Care and the UK devolved administrations, and leading health research charities.
